Mark Fowler called the meeting to order at 10:00 a.m. and asked attendees to introduce themselves. Mr. Fowler noted last meeting's summary notes were included in the agenda packet and directed anyone who needed the full transcript to contact Northwest Municipal Conference staff. Mr. Fowler introduced Paul Jacobs from the MWRD to provide an update on the watershed capital improvement projects since the last meeting. Mr. Jacobs noted that the MWRD launched a new website since the last meeting. He added that there are 133 Phase 1 and Phase 2 projects in the watershed, along with 20 space to grow projects in conjunction with Chicago Public Schools. He noted that, of those 133 projects, 42 are completed and 16 of the 20 space to grow projects are completed. Mr. Jacobs then provided details on the capital improvements projects in the watershed and the appropriate MWRD staff member contacts. Mr. Jacobs reviewed other programs and initiatives including the Phase II localized flood-control program, flood-prone property acquisition program, FEMA pre-disaster mitigation grant program, green infrastructure program, storm water master plan initiative and North Branch of the Chicago River stream and detention basin inventory. Mr. Jacobs noted that Phase II localized flood control applications would be sent out in the fourth quarter of 2019 and that notices of award for the FEMA pre-disaster mitigation grants would go out in June of 2020. Mr. Jacobs added that the green infrastructure applications were being reviewed and applicants would be notified of their selection in October 2019. He noted that MWRD is also developing Green Guides for the general public and municipal staff to use to determine best practices when implementing green infrastructure projects, and reminded municipal staff to fill out the stormwater master plan survey that was sent to them.

Mr. Jacobs provided an overview and update of the MWRD small streams maintenance program, which began in 2006. He provided information on the MWRD rain barrel program and Restore the Canopy initiative, and then introduced Mr. Cunico to give an update on the Watershed Management Ordinance (WMO). Mr. Cunico first noted the amendments approved by the MWRD Board of Directors on May 16. He said that a number of new forms have been released and encouraged everyone to make sure that they are accessing and submitting the newest forms by visiting the MWRD website. Mr. Cunico noted recent updates including those to the earth work foundation permit, single family home flowchart, utility work flowchart and technical guidance manual. With regard to the WMO changes, Mr. Cunico said that the release rate for the North Branch would remain at .3 CFS, and noted that users would have to clear their internet cache to access any new changes. He said MWRD added the updated Bulletin 70 rainfall data based on the latest Illinois state water survey along with the redevelopment allowances and methodologies. Mr. Cunico noted that these three WMO updates are effective January 1, 2020 and that the technical guidance manual will be updated based on the latest WMO amendments. Finally, Mr. Cunico reminded communities to submit their annual summary reports for the infiltration and inflow control program.

There being no further business, Mr. Fowler adjourned the meeting at 10:13 a.m.
