Satellite Entity 2018 IICP Annual Summary Report due March 1, 2019

The purpose of the IICP, defined in Article 8 of the Watershed Management Ordinance (WMO), is to reduce sanitary sewer overflows and basement backups, comply with the National Pollutant Discharge Elimination System (NPDES) permit requirements for the District's Water Reclamation Plants and minimize extraneous flows transported to District facilities. To achieve these goals, satellite entities that own or operate sanitary sewer systems discharging into District facilities are required to identify and address I/I sources within their public and private sewer systems.

The IICP consists of two parts: the Short Term Requirements (STR) and the Long Term Operation and Maintenance Program (LTOMP). The STR include a prioritized condition assessment of high risk public sewers, rehabilitation work to address high priority deficiencies (I/I sources) and the development of the Private Sector Program (PSP) and LTOMP. Once the STR are complete, satellite entities will transition to the LTOMP, under which they will implement their programs for on-going inspection, maintenance and rehabilitation of the public sewer system, and their PSP for the identification and correction of I/I sources in private sewer systems.

Since July 10, 2014, satellite entities have been working to complete the STR by the July 10, 2019, deadline. As required by the IICP, satellite entities report progress of this work by submitting an Annual Summary Report. Please submit a completed Annual Summary Report, along with the appropriate attachments, by March 1, 2019. The submittal can be emailed to mwrdii@mwrd.org.


