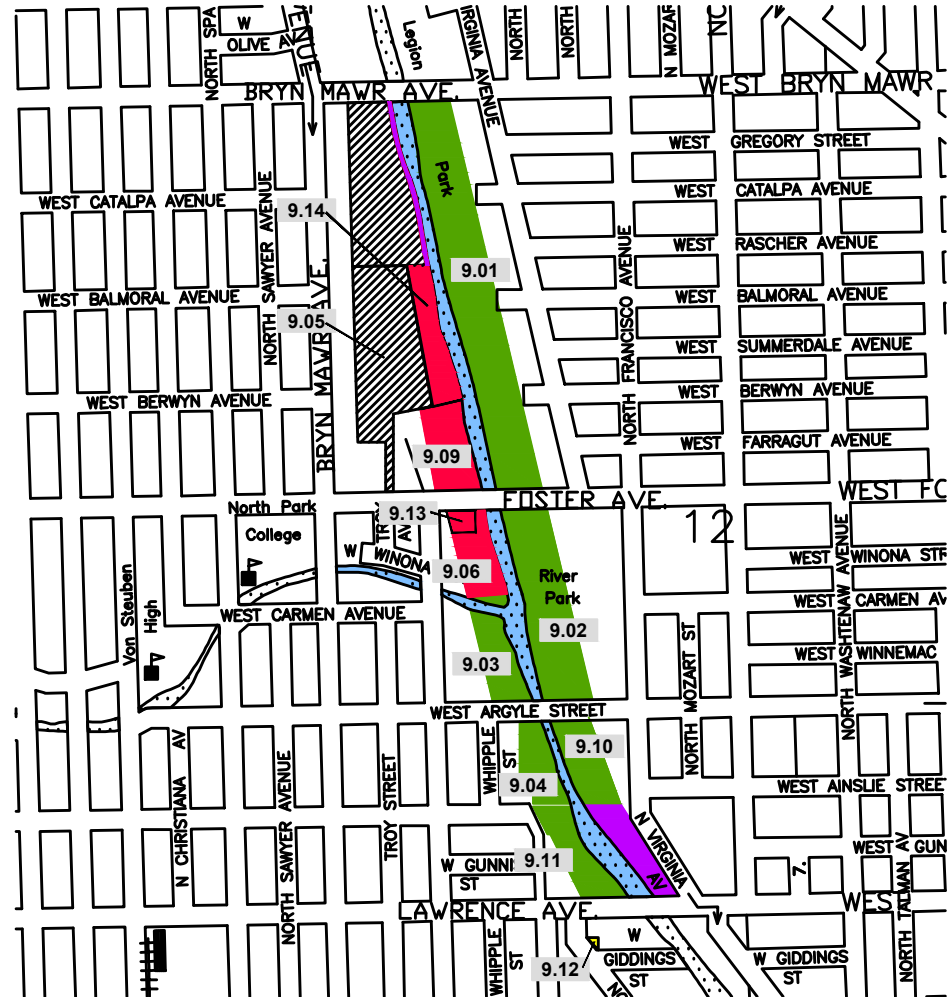


SCALE OF MILES
