1,500+ households participated in hazardous waste collection at Brookfield Zoo

More than 1,500 households delivered electronics, household cleaning products, antifreeze, weed killers and other types of hazardous waste products during a special collection held last month at the Brookfield Zoo. The Metropolitan Water Reclamation District of Greater Chicago (MWRD) partnered with the Illinois Environmental Protection Agency (IEPA) to sponsor the household hazardous waste (HHW) collection event.

"As a leader in protecting our environment, public health and water, the MWRD is happy to play a role in any recycling effort, especially with regards to household hazardous waste that can be properly disposed," said MWRD Commissioner Frank Avila.

Products that are toxic, flammable, or could cause a dangerous reaction when mixed with other chemicals or eat away at solid objects are household hazardous wastes. These products can pollute the environment and can make people sick if they are disposed of improperly. They should not be poured down the drain or into storm sewers. They also should not be thrown into the trash like regular garbage.

"Household hazardous waste poses a threat to air and water," said MWRD Commissioner Kimberly Du Buclet. "If not properly disposed, liquid contaminants can slip through our

systems and eventually discharge into local waterways and threaten our environment."
