Input Opportunities

- 1. Q&A sessions during presentations to the public (school/community groups), meetings of the District's Board of Commissioners, and biosolids contractor outreach efforts.

- 3. Telephone calls.
- 4. Freedom of Information Act (FOIA) requests.
- 5. See table below for a list of biosolids marketing and educational activities in which public input is welcome.

Interested Party Notifications

Interested parties, as identified on the *Interested Parties List*, will be notified in writing when the District:

- 1. Intends to conduct an Independent Third Party Verification Audit.
- 2. Is developing goals and objectives for the following year.

The letter will direct the interested party to find more information on the District's website and contact the District via e-mail but will advise the interested party that written or verbal communication will be accepted if computer access is not available.

Interested Parties

At a minimum, the Interested Parties list will include:

- 1. District biosolids contractors
- 2. Recipients of District biosolids through the Controlled Solids Distribution program
- 3. Chicago-area branches of government
- 4. Cook County municipalities and public works directors.
- 5. State Legislators and alderman.
