# Element 11 – Emergency Preparedness and Response

#### Purpose

The Emergency Procedures Manuals have been created to minimize response time to potential emergency situations, including situations that may result in problems with biosolids quality, public health and safety, or public acceptance of the District's biosolids management program.

The following describes the District's procedures for reviewing and revising the Emergency Procedures Manuals.

#### **Responsible Parties**

EMS Coordinator Division Heads Resident Engineers of the Biosolids Contracts

#### Procedures

- 1. On an annual basis in January, as part of the Internal Audit, the EMS Coordinator will send a memo directing the Division Heads to review their respective Emergency Procedures Manual(s). The Risk Manager is to be copied on the memo. If necessary, the Emergency Procedures Manual(s) will be revised, printed, and distributed to District staff.
- 2. Plant staff will initiate the review process without written direction any time an Emergency Procedures Manual is used in an actual emergency situation and revise if necessary.
- 3. Requirements for emergency procedures and response plans for biosolids contractors are located in the detail specifications of the contract documents. A list of all the biosolids contracts is on file with the EMS Coordinator.
- 4. A summary of changes to the Emergency Procedures Manuals related to the District's biosolids management program will be published in the *Biosolids Program and EMS Performance Report*, described in Element 15.
