This letter transmits information and data for the Metropolitan Water Reclamation District of Greater Chicago - Controlled Solids Distribution Program for June 2009, as required by Illinois Environmental Protection Agency Permit No. 2005-SC-3793

Sludge flow schematic diagrams for solids processed during June 2009 are shown in <u>Figure 1</u> - John E. Egan Water Reclamation Plant (WRP), <u>Figure 2</u> - Calumet WRP, and <u>Figure 3</u> - Stickney WRP.

Biosolids were distributed to seven sites in June. The user information report for those sites are presented in $\underline{\text{Table 1}}$, and the analyses of composited biosolids delivered to those sites are presented in Tables 2 - 8.





STICKNEY WATER RECLAMATION PLANT SOLIDS DISTRIBUTION FOR JUNE 2009 Figure 3


