Sludge flow schematic diagrams for solids processed during August 2010 are shown in $\underline{\text{Figure 1}}$ - John E. Egan Water Reclamation Plant (WRP), $\underline{\text{Figure 2}}$ - Calumet WRP, and $\underline{\text{Figure 3}}$ - Stickney WRP.

Biosolids were distributed to twelve sites in August. The user information report for those sites is presented in $\underline{\text{Table 1}}$, and the analyses of the composited biosolids delivered to those sites are presented in $\underline{\text{Table 2}}$.





STICKNEY WATER RECLAMATION PLANT SOLIDS DISTRIBUTION FOR AUGUST 2010 Figure 3


