The attached table contains the monitoring data for the Hanover Park Water Reclamation Plant (WRP) Fischer Farm site for April, May, and June 2023, as required by Illinois Environmental Protection Agency (IEPA) Operating Permit No. 2022-SC-66896, Special Condition 2. Analytical data for well water samples collected during the quarter are presented in <u>Table 1</u>.

Based on the investigation of historical high levels of ammonia nitrogen (NH₃-N) plus nitrite+nitrate nitrogen (NO₂-+NO₃-N) in Well 7 during past monitoring, it appears that the source of these high levels is seepage from adjacent lagoons and subsurface drainage associated with supernatant application, both of which have high NH₃-N levels. Since implementing management practices in 2019 to reduce the loading in adjacent lagoons and stop all applications of supernatant and biosolids in the closest farm field (Field 7), NH₃-N plus NO₂-+NO₃-N in Well 7 has shown a decreasing trend, but with some significant fluctuation. We will continue to implement these practices and evaluate this trend.
